FELIX TSHISEKEDI NAMED PRESIDENT OF THE DEMOCRATIC REPUBLIC OF CONGO



The Democratic Republic of Congo (DRC) is once again in the spotlight as President Felix Tshisekedi secures victory in the highly contested December 20 election.

President Tshisekedi emerged victorious with approximately 73% of the vote, leaving his closest rival, Moise Katumbi, with 18%. Felix Tshisekedi, the son of veteran opposition leader Etienne Tshisekedi, secured his first term in 2019.

The Democratic Republic of the Congo (DRC), located in Central Africa, is the largest country in sub-Saharan Africa with a diverse landscape and rich natural resources.

Despite its potential wealth, the country has a history marked by political instability, conflicts, and the exploitation of resources contributing to humanitarian crises.

BRICS GROUP TO DOUBLE IN 2024 AFTER Saudi, Iran, UAE, Egypt, Ethiopia Join Ranks



BRICS, the group of emerging-market nations comprising Brazil, Russia, India, China, and South Africa, is poised to undergo a significant expansion on January 1.

South Africa's envoy to the bloc revealed that Saudi Arabia, Iran, the United Arab Emirates, Ethiopia, and Egypt have accepted invitations to join, effectively doubling the organization's membership.

In August, the existing BRICS members extended invitations to six nations, including the aforementioned, aiming to combine leading energy producers with major consumers among developing countries. Argentina, the sole decline, reversed its membership bid under the new presidency of Javier Milei.

Representatives from the new invitees participated in a recent BRICS sherpa meeting in Durban, South Africa, indicating their acceptance of the invitation. The five countries are set to send officials to the next sherpa meeting in Moscow on January 30.

PUTIN KICKS OFF RUSSIA'S 2024 BRICS Chairmanship



On January 1, Russian President Vladimir Putin officially marked the commencement of Russia's 2024 BRICS Chairmanship. The overarching strategy will continue to promote BRICS partnerships in politics and security, economy and finance, as well as cultural and humanitarian contacts.

During this handover, President Putin emphasized the motto for the upcoming tenure, "Strengthen-



ing Multilateralism for Equitable Global Development and Security." This signifies Russia's commitment to fostering collaboration among the BRICS nations – Brazil, Russia, India, China, and South Africa President Putin articulated Russia's priorities, which encompass a wide array of sectors.

These include cooperation in science, high technology, healthcare, environmental protection, culture, sports, youth exchanges, and civil society.

IMF TO RELEASE \$700 MILLION BAILOUT TRANCHE TO PAKISTAN IN JANUARY



Cash-strapped Pakistan is poised to receive a crucial \$700 million bailout tranche from the International Monetary Fund (IMF) during the Executive Board meeting on January 11.

The disbursement, under the existing \$3 billion Stand-By Arrangement (SBA), is expected to provide much-needed financial support to Pakistan's struggling economy.

The IMF Executive Board is scheduled to discuss Pakistan's case on January 11, potentially granting final approval for the release of the \$700 million tranche. The current SBA, initiated in 2019, is set to conclude in April 2024, with approximately \$1.8 billion remaining undisbursed.

DENMARK'S QUEEN MARGRETHE II TO STEP Down After 52 Years On Throne

Applications for the 70,000 visas will be exclusively processed online, preventing them from being inundated among other visa requests. This groundbreaking initiative aligns with the EU's digitalization plans for Schengen visas, marking a significant shift in visa application procedures.

BHARAT COKING COAL LTD STARTS 5.0 MTPA MADHUBAND WASHERY OPERATIONS





UNION HOME MINISTER AMIT SHAH Approves ₹1,658 Crore Recovery And Reconstruction Plan For Joshimath



Joshimath, a town in Uttarakhand, faced severe challenges due to landslides and ground subsidence. The high-level central committee, led by Union Home Minister Amit Shah, approved a comprehensive recovery and reconstruction (R&R) plan amounting to ₹1,658.17 crore to address the aftermath of these natural disasters.

The fast reactor power generation company, Bharatiya Nabhikiya Vidyut Nigam Ltd (BHAVI-NI), based in Kalpakkam, is at the forefront of this initiative.

The undersea cable link, executed by Japanese firm NEC and laid by BSNL, promises 100 times faster internet for the residents of Lakshadweep. Covering 1,868 kilometers, it connects Kavaratti, Agatti, Amini, Kadmat, Chetlet, Kalpeni, Minicov, Androth, Kiltan, Bangaram, and Bitra. This initiative allows telecom companies to offer 4G, 5G, and high-speed broadband for the first time in the archipelago.

GUJARAT GOVERNMENT INKS AGREEMENTS WORTH \$86 BILLION AHEAD OF VIBRANT **GUIARAT GLOBAL SUMMIT**



In preparation for the upcoming biennial Vibrant Gujarat Global Summit, the Indian state of Gujarat has sealed preliminary investment deals totaling 7.17 trillion Indian rupees (\$86.07 billion) with 58 companies spanning sectors like energy, oil and gas, and chemicals.

With NTPC and Torrent Power leading the charge, these strategic investments signal a robust push by Gujarat to attract both foreign and domestic investors. This move is pivotal as Prime Minister Modi aims to bolster investment in the country ahead of the national elections, where he seeks a third term.

INDIA BOLSTERS NAVAL STRENGTH WITH \$5 BILLION AIRCRAFT CARRIER TO COUNTER **CHINA**




India is set to reinforce its naval capabilities with the addition of a \$5 billion aircraft carrier, signaling its strategic response to China's expanding naval influence in the Indian Ocean region.

The Defense Acquisition Council is expected to greenlight the acquisition of a second indigenous aircraft carrier, costing nearly 400 billion rupees (\$4.8 billion).

The new aircraft carrier is designed to accommodate a fleet of at least 28 fighter jets and helicopters, with a displacement of 45,000 tons. Notably, the carrier will be equipped with French Rafale jets, showcasing India's commitment to advanced military technology.

THREE ANTI-SUBMARINE WARFARE SHIPS FOR INDIAN NAVY LAUNCHED AT COCHIN SHIPYARD







On 30th November 2023, the Cochin Shipyard marked a significant milestone with the simultaneous launch of the first three ships in a series of eight Anti-Submarine Warfare (ASW) shallow water crafts commissioned by the Indian Navy.

The vessels, names INS Mahe, INS Malva and INS Mangrol, were unveiled in a ceremony attended by distinguished naval officials and their spouses.

Each Mahe class vessel measures 78 meters in length, 11.36 meters in width, with a draught of 2.7 meters. They have a displacement of 896 tonnes and can achieve speeds of up to 25 knots (approximately 45 km/h).

With an endurance of 1,800 nautical miles, these vessels are specifically designed to accommodate indigenously-developed sonars for underwater surveillance. The crew composition includes 57 personnel, including seven naval officers.

INDIA-UAE JOINT EXERCISE 'DESERT Cyclone 2024' Kicks Off In Rajasthan



The collaborative military exercise 'Desert Cyclone 2024' between India and the United Arab Emirates (UAE) is scheduled to take place in Rajasthan from January 2 to January 15. This joint manoeuvre aims to enhance interoperability through the exchange of knowledge and best practices, particularly in urban operations.

The robust friendship between India and the UAE is deeply rooted in enduring cultural, religious, and economic interactions that span millennia. In recent times, the collaboration in defence between India and the UAE has witnessed significant enhancement.

The cooperation extends to various aspects, including defence training, the supply of defence inventory, and the implementation of regular exchange programs. One notable milestone in this collaboration was the inaugural India-UAE Joint Air Forces exercise held in September 2008 at the Al-Dhafra base in Abu Dhabi.

DRDO CELEBRATES ITS 66TH FOUNDATION DAY



India's Defence Research and Development Organisation (DRDO) commemorated its 66th Foundation Day on January 1, 2024, marking a significant journey of innovation and self-reliance in the country's defence sector. The day was celebrated with great enthusiasm and a renewed commitment to bolstering India's defence capabilities.

Dr. Kamat stressed the importance of Aatmanirbharta (self-reliance) in defence production. He highlighted the record-breaking Acceptance of Necessity (AoN) accorded in 2023 for DRDO-developed systems worth over Rs. 1.42 lakh crore.

STRONG GROWTH IN GST COLLECTIONS: December 2023 Records ₹1.65-Lakh Crore



In a significant economic development, Goods and Services Tax (GST) collections for December 2023 reached ₹1,64,882 crore, marking a notable 10.28% surge compared to the ₹1,49,507 crore collected in the same month the previous year.

This accomplishment underscores the seventh consecutive month in the fiscal year where average GST collections have exceeded ₹1.6-lakh crore. Notably, November 2023 witnessed GST collections at ₹1,67,929 crore, contributing to the overall positive trend.

During the period of April-December 2023, Gross GST collections reached ₹14.97-lakh crore, exhibiting a commendable 12% increase from the ₹13.40-lakh crore recorded in the corresponding period of the previous fiscal year (April-December 2022).

INDIA INC'S INVESTMENT SLUMP PERSISTS IN FY24'S FIRST NINE MONTHS: BANK OF BARODA ANALYSIS



India's corporate sector investment in the first nine months (9M) of FY24, totaling ₹10.80 lakh crore, has raised concerns as it lags behind expectations, according to Bank of Baroda's Economic Research Department (ERD).

The analysis, relying on CMIE data, indicates a cautious approach among industries, with a particular focus on aviation, chemicals, machinery, and power sectors.

FY24 investments stand at ₹10.80 lakh crore, notably lower compared to ₹21.89 lakh crore in 9MFY22 and ₹13.22 lakh crore in 9MFY21.

The latest data, excluding the pandemic-hit



2020, reveals the lowest investment figures, emphasizing a hesitancy in the industry. Q3 FY24 witnessed a slight uptick at \gtrless 2.15 lakh crore, yet considerably below the figures from the past 10 quarters.

IND-RA RAISES INDIA'S FY'24 GROWTH Forecast To 6.7%: Factors And Challenges



India Ratings and Research (Ind-Ra) has revised its GDP growth estimate for the current fiscal year upward to 6.7% from the earlier 6.2%.

The upgrade is attributed to the resilience of the Indian economy, sustained government capex, a deleveraged corporate/banking sector balance sheet, and the potential for a new private corporate capex cycle.

The Reserve Bank of India anticipates a sequential slowdown in GDP growth in the last two quarters of FY24, projecting an overall GDP of 7%.

PMI MANUFACTURING HITS 18-MONTH Low At 54.9 In December Amid Festival Demand Slowdown



The HSBC India Purchasing Managers' Index

(PMI) for manufacturing dropped to an 18-month low of 54.9 in December, down from 56 in November, signaling a slowdown.

Despite this, the sector remains in expansion mode, marking 30 consecutive months with the index above 50, indicative of growth. The decline was attributed to a weaker rise in new orders and output.

The manufacturing sector continued to expand in December, albeit at a softer pace, maintaining growth momentum despite a decline. New business gains, favorable market conditions, fairs, and expositions contributed to a sharp increase in manufacturing during December.

FITCH FORECASTS STRONG GROWTH FOR ASIA PACIFIC EMERGING MARKETS IN 2024



Fitch Ratings released its report 'APAC Cross-Sector Outlook 2024', affirming robust economic growth in the Asia Pacific region.

The forecast highlights a 5% GDP growth in India and various emerging markets, indicating positive trends in the banking sectors of India and Indonesia.

Fitch anticipates a sustained economic upswing in Asia Pacific, with GDP set to expand by or above 5% in key nations such as India, Indonesia, the Philippines, and Vietnam.

Notably, China is expected to maintain a strong performance relative to global standards.

The Indian economy, which grew by 7.2% in the



2022-23 fiscal year, is projected to achieve GDP growth rates of 6.9% and 6.5% in the current fiscal year and 2024-25, respectively.

UPI ENDS 2023 WITH RECORD TRANSACTIONS WORTH ₹18-LAKH CRORE, UP 42% Y-O-Y



In December, UPI transactions soared by an impressive 42% year-on-year, reaching an astounding value of Rs 18 lakh crore. The transaction volume witnessed a substantial 54% rise, totaling 1,202 crore. Remarkably, the month-on-month growth in UPI transaction volume was a substantial 7%.

Fastag transactions experienced notable growth, with a volume of 34.8 crore in December, marking a 13% YoY increase. The value of these transactions also saw a substantial uptick, rising by 19% to Rs 5,861 crore compared to the same period last year. Furthermore, this figure is 10% higher than the recorded Rs 5,539 crore in November 2023


Tata Pay, the digital payments app under Tata Digital, has been granted a payment aggregator (PA) license by the Reserve Bank of India (RBI).

HOUSEHOLD FINANCIAL SAVINGS AND LIABILITIES IN INDIA: RBI'S ASSESSMENT



The Reserve Bank of India (RBI) released its latest Financial Stability Report (FSR), revealing insights into the state of household financial savings and liabilities in the fiscal year 2022-23 (FY23).

Despite a decline in gross household financial savings to 10.9% of GDP, the report emphasizes a limited risk of defaults by households, attributing it to the manageable exposure to higher mortgage payments and floating interest rates.

The FSR notes a significant increase in household financial liabilities, rising from 3.8% of GDP in FY22 to 5.8% in FY23.

This surge, driven by increased borrowings for physical asset creation, primarily in mortgages and vehicles, contrasts with a marginal moderation in financial assets to 10.9% in FY23 from 11.1% in FY22.
